AMENDMENT #2 TO STANDARD AGREEMENT between COUNTY OF MONTEREY and NELSON D. HOLMAN dba HOLMAN'S HOOK N' HAUL

THIS AMENDMENT #2 is made to the Standard Agreement by and between Nelson D. Holman dba Holman's Hook N' Haul (hereinafter "CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California, (hereinafter referred to as "County"); for towing and recovery services at Monterey County Parks WeatherTech® Raceway at Laguna Seca.

WHEREAS, the County and CONTRACTOR executed a Standard Agreement on August 13, 2020; and

WHEREAS, the County and CONTRACTOR executed Amendment #1 to the Standard Agreement on September 29, 2021; and

WHEREAS, the County and CONTRACTOR wish to further amend the Standard Agreement to increase the not-to-exceed sum of the Agreement.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Standard Agreement in the following manner:

- 1. Section 2.0 PAYMENT PROVISIONS is deleted in its entirety and replaced with: County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitation set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$300,000.
- 2. All other terms and conditions of the Original Standard Agreement, Amendment #1 and all Exhibits remain unchanged.
- 3. A copy of this Amendment #2 shall be attached to the original Standard Agreement, executed on August 13, 2020.
