**AN ORDINANCE OF THE COUNTY OF MONTEREY, STATE OF CALIFORNIA, AMENDING SECTION 12.44.180, SECTION 12.44.185, AND SECTION 12.44.200 OF THE MONTEREY COUNTY CODE RELATING TO THROUGH HIGHWAYS, STOP INTERSECTIONS, AND CROSSWALKS ON PRIVATE ROADS**

**County Counsel Summary**

*This ordinance establishes all way stop control on the Stevenson Drive, Forest Lake Road, and Alvarado Lane intersection and establishes crosswalks across Stevenson Drive west and south legs of the intersection in the unincorporated area of the County of Monterey by amending section 12.44.180 to remove subsection "B"; amending section 12.44.185 to remove subsection "U"; and amending section 12.44.200 of the Monterey County Code.*

The Board of Supervisors of the County of Monterey ordains as follows:

**SECTION 1. PURPOSE AND FINDINGS.** Pursuant to Article XI, section 7 of the California Constitution, the County of Monterey may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its citizens. California Vehicle Code section 21354 authorizes the County of Monterey to designate any highways as through highways, and erect stop signs at all entrances thereto or to designate any intersection under its exclusive jurisdiction as a stop intersection and erect stop signs at one or more entrances thereto.

**SECTION 2.** Section 12.44.180 of the Monterey County Code is amended to delete the following subsection:

**B. Alvarado Lane**, through its intersection with Stevenson Drive and Forest Lake Road through its intersection with Riata Road except at its intersection with 17 Mile Drive, making that intersection a four-way stop;

**SECTION 3.** Section 12.44.185 of the Monterey County Code is amended to delete the following subsection:

**U. Intersection of Forest Lake Road (SB) and Alvarado Lane**, stop required on Forest Lake Road (SB) at the entrance to Alvarado Lane;

**SECTION 4.** Section 12.44.200 of the Monterey County Code is amended to add the following:

**Stevenson Drive** south of Forest Lake Road;

**Stevenson Drive** at Hay Golf Course;

SECTION 5. This ordinance shall become effective on the thirty-first day following its adoption.
