RENEWAL AND AMENDMENT NO. 1 OF AGREEMENT BETWEEN THE COUNTY OF MONTEREY & Star Sanitation, LLC

THIS AMENDMENT NO. 1 to the Agreement between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and Star Sanitation, LLC, hereinafter "CONTRACTOR", is hereby entered into between the COUNTY and the CONTRACTOR, collectively the "Parties", and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into an Agreement with COUNTY on July 1, 2019, hereinafter "Agreement", to provide pumping and disposal services for septic tanks and lift stations for WeatherTech Raceway Laguna Seca through June 30, 2024 for an amount not to exceed \$100,000; and

WHEREAS, COUNTY has a continued need for services; and

WHEREAS, additional funding is necessary; and

WHEREAS, the Parties wish to amend the Agreement to increase the amount by \$350,000 for a total amount not to exceed \$450,000 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 1.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

Amend paragraph 4.02 to read as follows:

The total amount payable by County to CONTRACTOR under this agreement shall not exceed the sum of \$450,000
