 Authorize the Auditor-Controller’s Office to incorporate approved budget )  
 modifications to the FY 2021-22 Budget, and the County Administrative Office to )  
 reflect these approved changes in the FY 2022-23 Adopted Budget.

**WHEREAS**, the County certifies that the Small Business Revolving Loan Fund is being operated consistent with the EDA approved administrative plan; and,

**WHEREAS**, the County Administrative office (CAO) continues to support Economic Development by receiving grant funds from the U.S. Department of Commerce Economic Development Administration (“EDA”) for the County’s Small Business Revolving Loan Fund; and,

**WHEREAS**, expenses for the program, Small Business Revolving Loan Fund, receives grant funding from the U.S. Department of Commerce Economic Development Administration (“EDA”) through July 2022; and,

**WHEREAS**, an allocation of \$1,760,000 will fund the Economic Recovery efforts for the Small Business Revolving Loan Fund through July 23, 2022.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Board of Supervisors, in and for the County of Monterey, hereby:

Authorizes the Auditor-Controller to amend the FY 2021-22 for County Administrative Office Small Business Revolving Loan Fund (SBRLF) 011-1050-CAO040-8516 to increase appropriations by \$1,760,000 funded by CARES Act Federal EDA grant revenue (4/5<sup>th</sup> vote required)


