

**RENEWAL AND AMENDMENT NO. 1
TO THE SERVICES AGREEMENT
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND
SPOK, INC.
FOR
INTERNET CAPABLE PAGER SERVICES**

This Renewal and Amendment No. 1 to the Wireless Communication Services Agreement (“Agreement”) which was effective on July 1, 2016 is entered by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter “Customer”) and Spok, Inc. (hereinafter “Company”); (collectively, the Customer and Company are referred to as the “Parties”), with respect to the following:

RECITALS

WHEREAS, the Parties had previously entered into an Agreement for internet capable pager services on July 1, 2016 with a two (2) year term from July 1, 2016 through June 30, 2018 and a total Agreement amount not to exceed \$150,000; and

WHEREAS, the Agreement expired by its terms on June 30, 2018; and

WHEREAS, the Parties wish to renew and amend the Agreement on the same or similar terms, retroactive to July 1, 2018 to extend it for an additional one (1) year period through June 30, 2019 to allow for services to continue with a \$15,000 increase for a total Agreement amount of \$165,000.

AGREEMENT

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement incorporated herein by this reference, except as specifically set forth below.

1. First section of the Agreement shall be amended to the following:
THIS WIRELESS COMMUNICATION SERVICES AGREEMENT (the “Agreement”) is made and effective on July 1, 2016 (the “Effective Date”) by and between Spok, Inc. (“Company”) and the County of Monterey on behalf of Natividad Medical Center (“Customer”).
2. Section 2 titled “TERM OF AGREEMENT” first sentence shall be amended to the following:
This agreement had an initial term of July 1, 2016 through June 30, 2018 (the “Initial Term”). The parties agree to extend the agreement for one year through June 30, 2019.
3. Section 10.a titled “Prices” shall be amended to add the following last sentence:
“The total Agreement amount shall not exceed \$165,000.”
4. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 1, the provisions of this Renewal and Amendment No. 1 shall govern.
5. This Renewal and Amendment is effective retroactively on July 1, 2018.


