California Department of Aging (CDA) agreement with County of Monterey for \$1,478,429 for
the following existing programs: Fall Prevention, Title III and Title VII programs; and
WHEREAS, CDA provided \$1,390,844 in emergency funding for the American Rescue Plan
Act (ARPA) for the Fall Prevention Grant in the Amendment #3, which provides services for
eligible individuals who are at-risk of falling or being institutionalized by providing assessments,
consultations, and referrals. The Department will only use \$21,000 in the FY 2021-22, with the
remaining balance of \$1,369,844 to be incorporated into future budget years, with a term ending
September 2024; and
