

**AMENDMENT NO. 1 TO AGREEMENT  
BETWEEN COUNTY OF MONTEREY AND  
SALINAS VALLEY FORD SALES INC, DBA SALINAS COLLISION REPAIR**

**THIS AMENDMENT NO. 1** to Agreement No. A-14977 between the County of Monterey, a political subdivision of the State of California (hereinafter, “County”) and Salinas Valley Ford Sales Inc., dba Salinas Collision Repair (hereinafter, “CONTRACTOR”) is hereby entered into between the County and the CONTRACTOR (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

**WHEREAS**, on September 29, 2020, the Board of Supervisors approved Agreement No. A-14977 which CONTRACTOR (referred to as Salinas Valley Ford Sales, dba Salinas Collision Repair in Agreement) entered into with County on October 1, 2020 (hereinafter, “Agreement”) to provide auto body repair services for the County in response to Request for Quote #10751 (hereinafter “services”) through and including September 30, 2022 for an amount not to exceed \$250,000;

**WHEREAS**, additional time is necessary to allow CONTRACTOR to provide the services required by the County;

**WHEREAS**, it is necessary to increase the not to exceed amount by ten percent (10%), \$25,000, to allow CONTRACTOR to continue to provide the services required by the County; and

**WHEREAS**, the Parties wish to amend the Agreement to extend the term for one (1) additional year to September 30, 2023 and increase the not to exceed amount by ten percent (10%), \$25,000, for a new not to exceed amount of \$275,000 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 1.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3.1 of Section 3.0, “Term of Agreement,” to read as follows:  
  
The term Agreement is from October 1, 2020 through and including September 30, 2023, unless sooner terminated pursuant to the terms of this Agreement.
2. Amend the second sentence of Section 2.0, “Payment Provisions,” to read as follows:  
  
The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$275,000.
3. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
4. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
