In recognition of the **Filipino Women's Club of Salinas of Monterey County** on their ninety-second anniversary

**WHEREAS**, the Filipino Women's Club of Salinas was founded by civic spirited women, and has served as a support system and instrument for good work in the community since 1930; and

**WHEREAS**, the conception of the Filipino Women's Club of Salinas came from Luis Agudo in 1930, former owner and publisher of the Philippines Mail, he sought means of helping his community with the help of a few civic spirited women; and

**WHEREAS**, under the presidency of Nora De Asis, members raised money to help poor and sick Filipinos with food, clothing, medicine and hospitalization, and this became the primary purpose of the Filipino Women's Club of Salinas under a succession of presidents until 1943; and

**WHEREAS**, the Filipino Women's Club of Salinas raised money jointly with the National Filipino American Council to help the victims of Mt. Pinatubo in 1991, and these partnerships with other organizations symbolize leadership strategy to carry out the goal and objectives of the Filipino Women's Club of Salinas; and

**WHEREAS**, in 2008, the Filipino Women's Club of Salinas joined hands with Gawad Kalinga USA to support nation-building in the Philippines by raising funds and donating a very large amount to Gawad Kalinga USA to help build a home in Gawad Kalinga Village in the Philippines; and

**WHEREAS**, Filipino Women's Club of Salinas continues to contribute to charitable organizations, such as the Red Cross, the Salvation Army, Alliance on Aging, and continue to jointly participate with the Filipino Community of Salinas Valley in the Asian Festival, Pasko Sa Nayon, and other fundraising events to preserve the legacy of Faith, Worth, Courage, and Service; and

**WHEREAS**, Filipino Women's Club of Salinas has made tremendous strides in living up to its motto of Faith, Worth, Courage, and Service, and cultivate and promote friendliness, cooperation, understanding among ourselves, contribute to charitable organizations, encourage our children to pursue higher education by awarding annual scholarships to deserving high school graduates of Filipino descent, and preserving the Filipino cultural heritage.
