

**RENEWAL AND AMENDMENT NO. 2  
TO SERVICES AGREEMENT  
BETWEEN CALIFORNIA SHOCK TRAUMA AIR RESCUE (CALSTAR) AND  
NATIVIDAD MEDICAL CENTER  
FOR  
PATIENT TRANSFER COORDINATION AND FACILITATION SERVICES**

This Renewal and Amendment No. 2 to the Services Agreement ("Agreement") which was effective on December 15, 2014 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and CALSTAR Air Medical Services LLC (CALSTAR) through its All-Access Transfer Center ("A-ATC") (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

**RECITALS**

**WHEREAS**, the Agreement was executed for Patient Transfer Coordination and Facilitation Services with a term December 15, 2014 through December 14, 2017 and a total Agreement amount not to exceed \$100,000; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement to extend it for an additional three (3) year period through December 14, 2020 to allow for services to continue with a \$450,000 increase for a total Agreement amount of \$550,000 (the "Financial Cap").

**WHEREAS**, the Agreement expired on December 14, 2020; and

**WHEREAS**, the Parties wish to renew and amend the Agreement on the same or similar terms, beginning December 15, 2020 and to extend the term for an additional six (6) month period through June 30, 2021 for a revised full Agreement term of December 14, 2014 through June 30, 2021 to allow for services to continue with additions to the original scope of work attached hereto as "Exhibit A-2 as per Renewal and Amendment No. 2", with no increase, for a total Agreement amount not to exceed \$550,000.

**AGREEMENT**

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

1. The first sentence of Paragraph titled, "TERM OF AGREEMENT" shall be amended to the following: ***"The term of this Agreement is from December 15, 2014 through June 30, 2021, or until the date the sum of \$550,000 is earned by CONTRACTOR, whichever date is earlier, unless sooner terminated pursuant to the terms of this Agreement."***
2. Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement and Amendment No. are unchanged and unaffected by this Renewal and Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
3. A copy of this Renewal and Amendment No. 2 shall be attached to the Original Agreement.
4. This Renewal and Amendment No. 2 shall be effective when signed by both parties.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Renewal; and Amendment No. 2 on the basis set forth in this document and have executed this Renewal and Amendment No. 2 on the day and year set forth herein.
