

**AMENDMENT NO. 1
TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY & UNITED WAY OF MONTEREY
COUNTY**

THIS AMENDMENT is made to the AGREEMENT No. A-15050, for the provision of serving as the administrator of the COVID-19 Stipend Pilot program by and between the United Way of Monterey County, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into AGREEMENT No. A-15050 with a start date of December 1, 2020 and for a total not to exceed \$621,668;

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to increase the amount of the AGREEMENT by \$22,461 and extend the term an additional six (6) months.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2.0, “PAYMENT PROVISIONS” shall be amended by removing “The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$621,668.” and replacing it with “The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$644,129.”.**
- 2. Paragraph 3, “TERM OF AGREEMENT”, shall be amended by removing “The term of this Agreement is from December 1, 2020 to December 31, 2020, unless sooner terminated pursuant to the terms of this Agreement”, and replacing it with “The term of this Agreement is from December 1, 2020 to June 30, 2021, unless sooner terminated pursuant to the terms of this Agreement”.**
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.**
- 4. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated December 3, 2020.**
