

AMENDMENT NO. 2
To
340B Prime Vendor Participation Agreement
By and between
County of Monterey and
Cardinal Health 110, LLC. and Cardinal Health 112, LLC.

This Amendment No. 2 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as "County", and Cardinal Health 110, LLC. and Cardinal Health 112, LLC., hereinafter referred to as "Cardinal".

RECITALS:

WHEREAS, the County and Cardinal have entered into a 340B Prime Vendor Participation Agreement ("Agreement") to provide discounted outpatient pharmaceuticals to be shipped to eligible facilities for a period of July 1, 2018 to June 30, 2021; and

WHEREAS, on September 11, 2019, the County was awarded the Health Resource and Services Administration's (HRSA) H80 Grant, thereby designating County's current Federally Qualified Health Center Look-Alike (FQHC-LAL) covered entities as Federally Qualified Health Center (FQHC) facilities and; and

WHEREAS, the current facility numbers associated with this Agreement must be updated to reflect the new facility numbers generated by HRSA per the new FQHC designation; and

WHEREAS, County has registered a new FQHC facility which has been approved by HRSA with an effective on April 1, 2020; and

WHEREAS, County and Cardinal wish to add a new eligible facility location to this Agreement; and

WHEREAS, the County and Cardinal wish to amend the Agreement as specified below.

NOW THEREFORE, the County and Cardinal hereby agree to amend the Agreement, as follows:

1. "Section 1. Base Agreement; Definition of Facility, b." shall be replaced in its entirety as follows:
 - b. "Facility" means any pharmacy, hospital, clinic and/or other Facility which County owns, manages and/or operates. A list of all Facilities as of the Effective Date, including their respective "ship to" addresses and number of deliveries per week is attached to this LOP as Attachment 2 and is incorporated herein by reference. Additional Facilities may be added to Attachment 2 upon the mutual written agreement of Cardinal and County and


such agreement by Cardinal shall not be unreasonably withheld. When County requests that Cardinal set up any new 340B contract pharmacy(ies) pursuant to the 340B Drug Purchase Program established by the Veteran's Health Care Act of 1992, Section 340B of Public Law 102-585, County will pay Cardinal a one-time set-up fee of \$150.00 per 340B contract pharmacy. Cardinal Health will waive the \$150.00 set-up fee in the event that the Contract Pharmacy has at least \$150.00 in total sales during the first six (6) months following set-up. County must provide monthly volume projections and delivery schedule (frequency and specific days) for each 340B contract pharmacy to be set up by Cardinal Health PD. Deliveries to 340B contract pharmacies will be at a time of day determined solely by Distributor. Distributor shall provide a 24-hour, 7-day per week emergency delivery service. Distributor shall prepay the courier and related service charges for such orders and bill these courier fees separately to Participant. In addition, a flat fee of \$35 per emergency service shall be billed to cover added operational costs incurred by the Distributor. This operational cost shall cover the first 10 Lines of any emergency order. Any additional Lines order that are more than 10 Lines shall be charged \$5.00 per Line.

2. "Attachment 2 – Participant Facilities", is replaced by Amendment No. 2 to Attachment 2. All references in the Agreement to Attachment 2 shall be construed to refer to Amendment No. 2 to Attachment 2.
3. Except as specifically stated herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
4. A Copy of this Amendment No. 2 shall be attached to the Agreement.
5. The effective date of this Amendment No. 2 is April 1, 2020.
