Resolution 2022/23-03**

**RESOLUTION ORDERING A SPECIAL ELECTION IN THE SAN ARDO UNION
ELEMENTARY SCHOOL DISTRICT TO BE HELD ON JANUARY 3, 2023, AND
PROVIDING FOR THE PARTICIPATION THEREIN OF ELECTORS RESIDING IN
SAID DISTRICT, AND SPECIFICATIONS OF THE ELECTION ORDER**

SAN ARDO UNION ELEMENTARY SCHOOL DISTRICT

WHEREAS, a General Election was held and conducted in the San Ardo Union Elementary School District on November 8, 2022, pursuant to Resolution No. 20212022-5; and,

WHEREAS, a candidate contest was placed on the November 8, 2022 General Election ballot in the San Ardo Union Elementary School District pursuant to Resolution No. 20212022-5, which requested the election be consolidated with the Statewide General Election and conducted by the Monterey County Elections; and,

WHEREAS, the Registrar of Voters identified that the candidate contest did not appear on ballots in voting precincts 9327 and 9397 impacting a total of twenty-nine (29) ballots within the San Ardo Union Elementary School District boundaries due to a data migration issue compounded by a shortened redistricting period; and,

WHEREAS, in the Matter of the Registrar of Voters heard at the Monterey County Superior Court on November 29, 2022, a judge of the superior court granted an extension of the certification of results for the District to allow the Governing Board to call for a special election.

WHEREAS, Education Code Section 5322 requires this Governing Board to order elections held in this district; and,

WHEREAS, the San Ardo Union Elementary School District calls a special election to be held on January 3, 2023 for voting precincts 9327 and 9397 in order to submit to the twenty-nine (29) voters of said district the candidate contest.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the governing body of the San Ardo Union Elementary School District hereby orders a special election to be held on **January 3, 2023** for the purpose of allowing the twenty-nine (29) voters to cast their votes for the San Ardo Union Elementary School District Governing Board Member candidate contest.

BE IT FURTHER RESOLVED AND ORDERED that said governing body requests the Board of Supervisors of the County of Monterey to permit the Monterey County Elections Department to provide any and all services necessary for conducting the special election, and

BE IT FURTHER RESOLVED AND ORDERED that all costs will be assumed by the Monterey County Elections Department, and

BE IT FURTHER RESOLVED AND ORDERED that the contest shall appear on the ballot in substantially the same form as the ballot provided in the November 8, 2022 and any other content required by law will appear in the voter pamphlet and mail packet as presented in said election.
