- g. Support the appointment of Dan Ripke to the Committee as the Higher Education member.

SUMMARY:

The primary purpose of the Economic Development Committee is to advise the Board of Supervisors on appropriate economic development policies, programs, and activities to ensure a Countywide perspective in support of a diversified economy, higher paying jobs and an expanded revenue base for local government services, while preserving and protecting the County's agricultural, tourism and education economic base in collaboration with cities.

Janine Chicourrat

Janine Chicourrat is interested in serving as tourism sector member of the Committee. She has been a member of the community since 1998 and is a veteran hospitality professional. Her background includes working on capital projects, leading a team of over 300 employees, serving on a variety of non-profit boards, working with public/private partnerships and more.
