RENEWAL AND AMENDMENT NO. 4 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF MONTEREY AND MICHAEL BAKER INTERNATIONAL, INC.

THIS RENEWAL AND AMENDMENT NO. 4 to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California ("County"), and Michael Baker International, Inc. ("CONTRACTOR"), is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with County on April 25, 2016 ("Agreement") to provide affordable housing program administration services to update the existing lotteries and waitlists ("services") for the East Garrison Inclusionary Housing Program ("Project") through November 15, 2016 for an amount not to exceed \$1,750;

WHEREAS, Agreement was amended by the Parties on October 10, 2016 ("Amendment No. 1," including Exhibit A-1 – Scope of Services) to expand the original scope of the Agreement to include corroborating forty-seven (47) homebuyers' purchases of forty-seven (47) Workforce income level homes, as well as qualifying applicants to purchase moderate-income Inclusionary homes, and to extend the term for approximately nine (9) months through July 31, 2017, and to increase the amount by \$73,600 which resulted in a total not to exceed amount of \$75,350;

WHEREAS, Agreement was amended by the Parties on June 29, 2017 ("Amendment No. 2") to extend the term for three additional (3) years through July 31, 2020 with no increase in the not to exceed amount;

WHEREAS, Agreement was amended on May 20, 2020 ("Amendment No. 3") to extend the term for two (2) additional years to July 31, 2022; update the fee for Workforce II review and number of Workforce II applicants, and to increase the amount by \$14,650 for a total not to exceed amount of \$90,000;

WHEREAS, the Agreement expired by its own terms on July 31, 2022;

WHEREAS, the Parties wish to renew the Agreement to allow additional time for the CONTRACTOR to provide Workforce II home buyer qualification services; and

WHEREAS, the Parties wish to amend the Agreement to extend the term for two (2) additional years to July 31, 2024 with no increase in the not to exceed amount of \$90,000.

NOW, THEREFORE, the Parties agree to renew and amend the Agreement as follows:

1. This Agreement is hereby renewed and amended retroactive to August 1, 2022, and all of its prior terms and conditions shall be deemed to have been in effect continuously since that time.

The term of this Agreement is from <u>April 25, 2016</u> to <u>July 31, 2024</u>, unless sooner terminated pursuant to the terms of this Agreement.
