Administrative hearing to consider allowing commercial cannabis cultivation and nursery, self-distribution and processing within 176,590 square feet of greenhouses, a metal building and storage containers.

Project Location: 25700 Encinal Road, Salinas

Proposed CEQA action: Consider an adopted Mitigated Negative Declaration and Addendum

RECOMMENDATIONS

It is recommended that the HCD Chief of Planning adopt a resolution to:

- a. Consider the adopted Multi-Site Cannabis Initial Study/Mitigated Negativie Declaration and Addendum (HCD Planning File No. REF150048, State Clearinghouse No. SCH2020060325), pursuant to CEQA Guidelines Section 15162; and
- b. Approve an Administrative Permit to allow commercial cannabis uses within 176,590 square feet of structures. The project includes cannabis nursery and cultivation within 168,881 square feet of greenhouses; processing, storage, fertigation, and loading within 6,909 square feet of storage containers and one metal building; and an 800 square foot office for security and sales (non-retail) personnel and restroom facilities.

The attached draft resolution includes findings and evidence for consideration (**Exhibit A**). Staff recommends approval subject to 17 conditions of approval.

SUMMARY

Staff is recommending approval of an Administrative Permit subject to the findings and evidence in the attached Resolution (see **Exhibit A**), and subject to the conditions of approval attached to the Resolution. Note: This project will be referred to the Monterey County Zoning Administrator if a public hearing is necessary. The decision on this project is appealable to the Planning Commission.
