WHEREAS, since 2009 **Sam McLeod** served, and has spent thousands of hours, on the Monterey County Sheriff's Emergency Assistance Team (SEAT), which assists the Monterey County Sheriff's Office and other Monterey County Public Safety agencies during public emergencies or when otherwise requested; and

WHEREAS, **Sam McLeod** was always first to respond to call-outs and volunteer for special events and was the only member to sign up for every shift during the 2019 U.S. Open, transporting deputies to their respective posts at the Pebble Beach golf course which involved getting up at 4:00 a.m. and sometimes working a double shift; and

WHEREAS, in 2019, **Sam McLeod** was inducted into the Monterey County Sheriff's Advisory Council Wall of Fame at the Monterey County Sheriff's Office; and

WHEREAS, **Sam McLeod** is also an associate member of the Monterey County Peace Officers Association (MCPOA), a non-profit organization that serves the Law Enforcement and Fire Professionals of Monterey County; and

WHEREAS, **Sam McLeod** made it his business to give back to his community with his time and many talents which can be seen in his contributions while serving in all his various roles.
