I am interested in the issues of childcare, education, housing, health, equal pay, and other related areas. As a woman of color, I have had to navigate around these barriers and obstacles that have impede access to many opportunities. Over 40 years as an educator in grades: preschool, kindergarten, primary grades, middle grades, high school, and college. I have been a full-time Hartnell College Early Childhood Education Instructor focusing on training and curriculum for parents, child care providers, family child care providers, teachers and teacher assistants. I also have been a commissioner for Monterey County First Five, active participant in ECE professional organizations, Child Development Training Consortium, and California Mentor Program.

Since the 1980s, I have had first-hand experiences and frustration accessing affordable quality childcare, advocating quality education for my own children, and participating in groups advocating for equal pay. Now 2022, my own adult children are dealing with childcare, access to special needs services, housing, and health. As a professional, I have worked with agencies with funding to find or establish additional infant/toddler and preschool early care and education centers. It has been difficult to find available space and/or organizations with space for child care centers. I have worked with female adult students who have struggled with housing, childcare, education, health etc. Even though I do provide information and invite guest speakers about the programs, the students soon learn that services do not meet the high demand and need in the community.
