Memorandum of Understanding Between the County of Monterey and the Monterey Peninsula Unified School District

This Memorandum of Understanding (MOU) is between the County of Monterey, a political subdivision of the State of California (hereinafter "COUNTY") and Monterey Peninsula Unified School District (hereinafter "VENDOR").

1.0 <u>Background:</u> Monterey County Health Department Cannabis Education Program (Cannabis Program) is an awardee of Board of State and Community Corrections (BSCC) funding. BSCC grant funds will provide capacity for Cannabis Program staff to administer cannabis education and prevention utilizing the Cannabis Awareness & Prevention Toolkit (CAPT) to various middle and high school aged children within the Monterey Peninsula Unified School District.

CAPT is a theory based and evidence informed education resource aimed at preventing and delaying middle and high school students use of cannabis and encouraging those who are using to cut back or quit use. The CAPT curriculum is non-judgmental with an overarching goal of protecting youth from cannabis exposure at this critical time of brain development. To expand education capacity, CAPT can be provided remotely to students and includes components that address the increased risk of COVID-19 infection from smoking and or vaping cannabis.

- 2.0 Term: Subject to funding, this MOU will become effective on upon execution and end on September 30, 2023. This MOU may be amended in writing by both parties. Either party may terminate this MOU with a thirty (30) day advance written notice.

- **4.0** <u>COUNTY Responsibilities:</u> COUNTY staff shall implement the Cannabis Education Program BSCC grant activities and conduct the following at participating schools: as described in Exhibit A.
- 5.0 <u>VENDOR Responsibilities:</u> VENDOR will provide the following by September 30, 2023: participate in program performance evaluation, provide Cannabis Program Staff information on students identified to participate in the intervention and provide assistance for CAPT planning and implementation.
- Mutual Indemnification: COUNTY hereby agrees to indemnify, defend, and save harmless Monterey Peninsula Unified School District (VENDOR) and its officers, agents, and employees, to the extent permitted by applicable law, from and against any and all claims and/or losses whatsoever accruing or resulting to any person, firm or corporation for damages, injury, or death incurred by reason of any act or failure to act by COUNTY or COUNTY's officers, agents, and employees in connections with the performance of this Agreement.
- 6.1 Monterey Peninsula Unified School District (VENDOR) hereby agrees to indemnify, defend and save harmless COUNTY and its officers, agents and employees, to the extent permitted by applicable law, from and against any and all claims and/or losses whatsoever accruing or resulting to any person, firm or corporation for damages, injury, or death incurred by reason of any act or failure to act by VENDOR officers, agents and employees in connection with the performance of this Agreement.
- 6.2 Both parties are responsible for providing proof of insurance or self-insurance for: (a) commercial general liability insurance or a program of self-insurance, including but not limited to premises, personal injuries, products, and completed operations, with a combined single limit of not less than \$1,000,000 per occurrence and (b) workers' compensation insurance in accordance with California Labor Code section 3700 or an authorized program of self-insurance, with a minimum of \$1,000,000 per occurrence for employer's liability. Both parties shall list the other as the certificate holder as follows:

Scope of Services / Payment Provisions

B. PAYMENT PROVISIONS

B.1 COMPENSATION/ PAYMENT

County shall pay an amount not to exceed \$0.00 for the performance of <u>all things necessary</u> for or incidental to the performance of work as set forth in the Scope of Work. B.2 CONTRACTORS BILLING PROCEDURES

County may, in its sole discretion, terminate the contract or withhold payments claimed by CONTRACTOR for services rendered if CONTRACTOR fails to satisfactorily comply with any term or condition of this Agreement.

No payments in advance or in anticipation of services or supplies to be provided under this Agreement shall be made by County.

County shall not pay any claims for payment for services submitted more than twelve (12) months after the calendar month in which the services were completed.

DISALLOWED COSTS: CONTRACTOR is responsible for any audit exceptions or disallowed costs incurred by its own organization or that of its subcontractors.
