

**AMENDMENT NO. 4**  
**To**  
**340B Prime Vendor Participation Agreement**  
**By and between**  
**County of Monterey and**  
**Cardinal Health 110, LLC and Cardinal Health 112, LLC**

This Amendment No. 4 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as “County”, and Cardinal Health 110, LLC and Cardinal Health 112, LLC., hereinafter referred to as “Cardinal”.

**RECITALS:**

WHEREAS, the County and Cardinal have entered into a 340B Prime Vendor Participation Agreement (“Agreement”) to provide discounted outpatient pharmaceuticals to be shipped to eligible facilities for a period of July 1, 2018 to June 30, 2021; and

WHEREAS, on September 11, 2019, the County was awarded the Health Resource and Services Administration’s (HRSA) H80 Grant, thereby designating County’s current Federally Qualified Health Center Look-Alike (FQHC-LAL) covered entities as Federally Qualified Health Center (FQHC) facilities; and

WHEREAS, on January 1, 2020, County and Cardinal entered into an executed Amendment No. 1 to add new eligible facility locations to this Agreement; and

WHEREAS, on April 1, 2020, County and Cardinal entered into an executed Amendment No. 2 to add a new HRSA approved FQHC facility; and

WHEREAS, on July 1, 2021, County and Cardinal entered into an executed Amendment No. 3 to extend the term of this Agreement another 13 months for a new term of July 1, 2018, to August 31, 2022; and

WHEREAS, the County and Cardinal wish to amend the Agreement to extend the Term of this Agreement and add a new eligible facility as specified below.

NOW THEREFORE, the County and Cardinal hereby agree to amend the Agreement as follows:

1. Section 2. “TERM” is hereby amended and restated to read in its entirety as follows:  
“This LOP shall be effective beginning on July 1, 2018 and continue through August 31, 2023 (the “LOP Term”) with an option, if the Base Agreement Term is extended, to extend the LOP Term for one (1) additional three (3) year period upon receipt by Distributor of ninety (90) days prior written notice from Participant.”

2. “Attachment 2 – Participant Facilities”, is replaced by Amendment No. 4 to Attachment 2. All references in the Agreement to Attachment 2 shall be construed to refer to Amendment No. 4 to Attachment 2.
3. Exhibit B – Returned Goods Authorization Ongoing Assurance, is hereby added to this Agreement.
4. Except as specifically stated herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 4 and shall continue in full force and effect as set forth in the Agreement.
5. A Copy of this Amendment No. 4 shall be attached to the Agreement.
6. The effective date of this Amendment No. 4 is September 1, 2022.

**CARDINAL HEALTH RETURNED GOODS AUTHORIZATION  
ONGOING ASSURANCE**

The undersigned customer (“**Customer**”) of Cardinal Health, (the “**Distributor**”) hereby agrees that this document is being delivered to confirm Customer’s compliance with applicable federal, state, and local laws / guidelines concerning returned goods and shall apply to all returns by Customer to Distributor from time to time and shall supersede any inconsistent provisions which may be contained in any credit request, purchase order, or other documents pertaining to the supply relationship between Customer and Distributor.

Customer represents, warrants, and guarantees to Distributor that: (a) each such return shall be made only to the specific Distributor from which the item was originally purchased; (b) each such return shall be accompanied by Distributor’s credit request form (the “**Return Form**”), which shall specify both Customer’s and Distributor’s name and address, the date of the return, the quantity and description of the product returned, and such other information as may reasonably be requested on Distributor’s Return Form; (c) Customer shall retain a copy of each Return Form and related credit memo and make such documentation available to the manufacturer and to authorized federal, state, and local law enforcement officers upon request; (d) the credit claimed or accepted by Customer for any such return shall not exceed the original purchase price paid to Distributor; and (e) all merchandise returned to Distributor has been stored and handled by Customer in accordance with all applicable federal, state, and local laws, manufacturer guidelines when disclosed to customer by the manufacturer or distributor, and good trade practices, and such merchandise has not been adulterated or misbranded by customer within the meaning of the Federal Food, Drug, and Cosmetic Act and meets all FDA, state, and other applicable requirements and guidelines.
