This Amendment No. 1 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as "County", and Cardinal Health 110, LLC. and Cardinal Health 112, LLC., hereinafter referred to as "Cardinal".

#### RECITALS:

WHEREAS, the County and Cardinal have entered into a 340B Prime Vendor Participation Agreement ("Agreement") to provide discounted outpatient pharmaceuticals to be shipped to eligible facilities for a period of July 1, 2018 to June 30, 2021; and

WHEREAS, on September 11, 2019, the County was awarded the Health Resource and Services Administration's (HRSA) H80 Grant, thereby designating County's current Federally Qualified Health Center Look-Alike (FQHC-LAL) covered entities as Federally Qualified Health Center (FQHC) facilities and; and

WHEREAS, the current facility numbers associated with this Agreement must be updated to reflect the new facility numbers generated by HRSA per the new FQHC designation; and

WHEREAS, County and Cardinal wish to add new eligible facility locations to this Agreement; and

WHEREAS, the County and Cardinal wish to amend the Agreement as specified below.

NOW THEREFORE, the County and Cardinal hereby agree to amend the Agreement, as follows:

- 1. Attachment 2 Participant Facilities, is replaced by Amendment No. 1 to Attachment 2. All references in the Agreement to Attachment 2 shall be construed to refer to Amendment No. 1 to Attachment 2.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 3. A Copy of this Amendment No. 1 shall be attached to the Agreement.
- 4. The effective date of this Amendment No. 1 is January 1, 2020.

(Cardinal) for the purchase of discounted outpatient pharmaceuticals for the County of Monterey Health Department's Federally-Qualified Health Center Look-alike clinics, for the term of July 1, 2018 to June 30, 2021 with the option to extend, based on ninety (90) days' written notice, for one (1) additional three (3) year period, for a total not to exceed maximum of six (6) years; and

b. Accepted the recommendations of the Director of Health or Assistant Director of Health regarding the following non-standard provision in the Letter of Participation: limitation of liability, insurance, and indemnification; and

c. Authorized the Director of Health or Assistant Director of Health to sign up to two (2) future amendments to this Letter of Participation where the amendments do not extend the term of the Letter of Participation and do not significantly change the scope of work; and

d. Authorized the Director of Health or Assistant Director of Health to exercise the option to extend. based on ninety (90) days' written notice, which, if exercised, shall extend the term for one (1) additional three (3) year period, for a revised full term of July 1, 2018 to June 30, 2024.
