## RENEWAL AND AMENDMENT NO. 3 TO THE SERVICES AGREEMENT

BETWEEN COUNTY OF MONTEREY ("COUNTY"), FOR THE PROVISION OF SERVICES AT NATIVIDAD MEDICAL CENTER, A COUNTY-OWNED AND OPERATED ACUTE CARE FACILITY

# SALINAS VALLEY MEMORIAL HOSPITAL (SVMH) FOR LABORATORY TESTING SERVICES

This Renewal and Amendment No. 3 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey ("County"), for the provision of services at Natividad Medical Center, a County-owned and operated acute care facility and Salinas Valley Memorial Hospital (SVMH) (hereinafter "CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

#### RECITALS

WHEREAS, the County of Monterey ("County"), for the provision of services at Natividad Medical Center, a County-owned and operated acute care facility and Salinas Valley Memorial Hospital (SVMH) had previously entered into an Agreement for Services (hereinafter "Agreement") on July 1, 2015 to provide laboratory testing services to NMC with a forty (40) month period through October 31, 2018 and a total Agreement amount not to exceed \$432,000; and

WHEREAS, the Parties amended the Agreement via Amendment No. 1 to extend it for an additional thirty-six (36) month period through October 31, 2021 to allow for services to continue with a \$500,000 increase for a revised total Agreement amount of \$932,000; and

WHEREAS, the Parties amended the Agreement via Amendment No. 2 to add an additional \$185,000 for a total Agreement amount of \$1,117,000 with no changes to the scope of work or Agreement term of July 1, 2015 through October 31, 2021; and

WHEREAS, the Agreement expired on October 31, 2021; and

WHEREAS, the Parties wish to renew and amend the Agreement via Renewal and Amendment No. 3 on the same or similar terms, beginning November 1, 2021 and to extend the term for an additional three (3) year period through October 31, 2024 for a revised full Agreement term of July 1, 2015 through October 31, 2024 to allow for services to continue with no changes to the scope of work and to increase the amount payable by \$782,000 for a total Agreement amount of \$1,899,000.

### **AGREEMENT**

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement and in Amendment No. 1 and Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

- "TERM OF AGREEMENT" Section shall be amended to the following:
   "The term of this Agreement is from July 1, 2015 through October 31, 2024 unless sooner terminated pursuant to the terms of this Agreement".
- 2. "PAYMENTS BY COUNTY" Section shall be amended to the following:
  "COUNTY" shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$1,899,000."
- 3. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 3, the provisions of this Renewal and Amendment No. 3 shall govern.
- 4. This Renewal and Amendment is effective retroactively on November 1, 2021.
