

**AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY, THROUGH ITS INFORMATION TECHNOLOGY
DEPARTMENT AND COMMSCOPE TECHNOLOGIES, LLC DBA COMSEARCH**

THIS AMENDMENT NO. 1 is made to the STANDARD AGREEMENT by and between the County of Monterey, a political subdivision of the State of California, (hereinafter referred to as “COUNTY”), and CommScope Technologies, LLC dba Comsearch, (hereinafter “CONTRACTOR”).

WHEREAS, the COUNTY and CONTRACTOR entered into a non-standard AGREEMENT in the amount of \$20,750 for the term October 10, 2017 to October 9, 2022 for Federal Communications Commission (FCC) license management services; and

WHEREAS, the COUNTY and CONTRACTOR wish to increase the amount by \$13,650, and extend the term through October 31, 2025 to continue FCC license management services.

NOW THEREFORE, the COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **2.0, “PAYMENT PROVISIONS” shall be amended by removing** The total amount payable by County to CONTRACTOR under this agreement is not to exceed the sum of \$20,750.00” **and replacing it with** The total amount payable by COUNTY to CONTRACTOR under this agreement is not to exceed the sum of \$34,400.00.
2. **3.0, “TERM OF AGREEMENT”** shall be amended by removing “The term of this Agreement is from October 10, 2017 to October 9, 2022” **and replacing it with** “The term of this Agreement is from October 10, 2017 to October 31, 2025.
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this AMENDMENT No. 1 and shall continue in full force and effect as set forth in the AGREEMENT.

A copy of this AMENDMENT No. 1 shall be attached to the original Agreement.
