WHEREAS, the recent vacancy of an Auditor-Controller Analyst I position has created an opportunity to reorganize the General Accounting Division to a more sustainable, efficient, and effective long-term structure;

WHEREAS, the General Accounting Division's workload has increased in volume and complexity, due to new Governmental Accounting Standards Board (GASB) pronouncements;

WHEREAS, Governmental Accounting Standards Board (GASB) pronouncements impact the complexity and size of the Annual Comprehensive Financial Report (ACFR), and the preparation and completion of the County-wide Cost Allocation Plan, Single Audit, and other financial reports;

WHEREAS, the reallocation of this position to a higher-level classification is critical to provide oversight of the implementation of GASB pronouncements, financial reporting, and to perform increasingly complex accounting and financial analysis;

WHEREAS, to implement the recommendation, the actions require the Fiscal Year 2022-23 Adopted Budget to be amended:
