WHEREAS, Congress has enacted the Housing and Community Development Act of 1974, as amended;

WHEREAS, Title I of the Act provides for a program of Community Development Block Grants;

WHEREAS, Title I of the Act makes entitlement grants available to cities with a population of 50,000 or more persons and to counties that qualify as an Urban County;

WHEREAS, the County of Monterey applied for and was designated an Urban County in September of 2012 in order to receive direct entitlement funds under the Act.;

WHEREAS, the parties hereto wish to enter into an agreement to enable the County of Monterey to apply for renewal and receive entitlement funds as an Urban County and to establish the respective rights and obligations of the contracting parties to such funds;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors does hereby authorize the County Administrative Officer to enter into a Joint Exercise of Powers Agreement and Cooperation Agreement with the cities of Gonzales, Greenfield, and Sand City to undertake or to assist in the undertaking of essential activities pursuant to Title I of the Housing and Community Act of 1974, as amended, for the period of October 1, 2015 to September 30, 2018.

NOW, BE IT FURTHER RESOLVED that the Board of Supervisors does hereby approve the application to the U.S. Department of Housing and Urban Development to designate Monterey County as an Urban County for purposes of the Community Development Block Grant program.
