WHEREAS, Detective Kevin Gardepie was born in 1965 and was raised and educated in Salinas, California where he attended North Salinas High School, graduated in 1983, and attended Hartnell College, obtaining his Associates of Science in Administration of Justice; and

WHEREAS, Detective Kevin Gardepie began his law enforcement career in 1987 with the Monterey County Sheriff's Office; and

WHEREAS, Detective Kevin Gardepie came to the Monterey County Sheriff's Office after working in management within the food and retail industries; and

WHEREAS, Detective Kevin Gardepie was sworn in on August 27, 1987 by Sheriff D.B. *Bud* Cook, and over his career, served for six Monterey County Sheriffs which included D.B *Bud* Cook, Norm Hicks, Gordon Sonné, Mike Kanalakis, Scott Miller, and Steve Bernal; and

WHEREAS, Detective Kevin Gardepie performed exceptionally well as a Deputy Sheriff, enjoying his role as a member of the Monterey County Sheriff's Office, and this is evident by the many positions he held which include Corporal, Field Training Officer Patrol, Search and Rescue, Hostage Negotiations - Team Leader, and Detective; and

WHEREAS, Detective Kevin Gardepie was promoted to Detective on January 14, 2009, and retires as a Detective in the Investigations Division; and
