**WHEREAS, Deputy Herman Campos** was born in 1957 and raised in Carmel, California. He was educated in Monterey, California, graduating from York High School in 1975, and attended Monterey Peninsula College; and

**WHEREAS, Deputy Herman Campos** began his law enforcement career in 1989 with the Monterey County Sheriff's Office as a citizen volunteer, becoming a fulltime Deputy Sheriff in 2009; and

**WHEREAS, Deputy Herman Campos** came to the Monterey County Sheriff's Office after working in the transportation and produce industries; and

**WHEREAS, Deputy Herman Campos** was sworn in as a full time Deputy Sheriff by Sheriff Mike Kanalakakis, after successfully completing the six month police academy in 2009, and over his career, including his volunteer and reserve deputy period, and served under five Monterey County Sheriffs which include Norm Hicks, Gordon Sonn , Mike Kanalakakis, Scott Miller, and Steve Bernal, and during his tenure in the Court Services Division, Deputy Campos was the bailiff for the Honorable Judge Adrienne Grover and the Honorable Judge Timothy Roberts; and

**WHEREAS, Deputy Herman Campos** performed exceptionally well as a citizen volunteer, Reserve Deputy Sheriff, and Deputy Sheriff, where he enjoyed his role as a member of the Monterey County Sheriff's Office, as evidenced by the many positions he held which include volunteer member of the Search and Rescue Team from 1989 to 1991, volunteer member of Sheriff's Emergency Assistance Team from 1991 to 1999, volunteer member of the Sheriff's Advisory Council from 1991 to 2008, Reserve Deputy Sheriff assigned to the Patrol Division from 1999 to 2008, Motor Squad member from 2005 to 2009, sworn Deputy Sheriff working in the Custody Operations Bureau from 2009 to 2011, and the Court Services Division as a Bailiff from 2012 to 2015; and

**WHEREAS, Deputy Herman Campos**, over his career received praise from citizens, staff, community organizations, and law enforcement agencies for his exceptional work, team work, and community commitment, and received a commendation in 1993 for being S.E.A.T. volunteer of the year; and
