Written Communications and Correspondence

Our Fish & Game Commission received a letter of gratitude from the California Legislative Outdoor Sporting Caucus for the Commissions support of the 2016 Annual Trap & Skeet Shoot.

CA Department of Fish & Wildlife Report - Captain Don Kelly

Captain Kelly introduced Game Warden Lieutenant Moore who is slated to take over Captain Kelly's position after his retirement. Warden Moore has been with CA Fish & Wildlife for 18

years. He started his career in Stockton and is now with the Central Coast region since 2014. Commissioners welcomed Warden Moore.

Captain Kelly gave a brief update on the Soberanes Fire and on his role as the state agency rep to incident command. He takes the concerns and considerations on behalf of state biologists to command staff. People have reported seeing bears, mountain lions, and coyotes as they are being pushed from the area.

Currently, his department is operating at 90% because of three openings: the Salinas warden moved north, and there is still an opening on the boat and in Santa Cruz.

Financial Report

Of the \$33,463 available as grant funding, only \$26,545.50 has been allocated, leaving \$6,917.50.

New Business

Guest Speakers

- Dan Haifley of O'Neill Sea Odyssey presented a report on the grant funding his organization received from the Propagation Grant Fund Program. Mr. Haifley noted that the funds were spent on the transportation for Monterey County Stewards. The educational program operates on the O'Neill catamaran out of Santa Cruz. The program consists of a one day science field trip that focuses on navigation, marine science, studying plankton, and conservation by observing sea otter and kelp forest habitat and onshore habitat looking at non-point source pollution. Their program curriculum is set to go nationally. The program has served over 9000 students since 1996. A college study done by a former student found that 75% of high school students retained stewardship principals and knowledge from their participation in the program while in elementary school. The grant funding allocated from the Monterey County Fish and Game Commission provided transportation for two classes from Marina and five classes from Santa Lucia Elementary School in King City. A 20-year celebration is scheduled for 17 September 2016 at the Seymour Marine Discovery Center in Santa Cruz.
- Aaron Palacios, Rancho Cielo Youth Corps Program Director, returned to thank the
 commission for grant funding for their program. Rancho Cielo is directed toward at-risk
 youth, providing them with job skills, transitional housing, and a job placement program.
 About 80% of the participants are on probation or parole. The 6-month long program
 includes 2 days of vocational training and 3 days of academic studies a week with the end
 goal of earning a high school diploma and a job.
- Mike Stake of Ventana Wildlife Society also returned to thank the Commission for the
 grant funding utilized in purchasing non-lead ammo for Monterey County residents that
 entered their monthly drawing. At the cost of approximately \$40/box, 100 applicants
 received their ammo. Drawings were held for June, July, and August. Participation was

up significantly for the months of July and August, mostly due to word of mouth advertisement. A proposed Senate bill limiting internet ammunition sales may create hurdles for their program, but they are determined to continue their program until no additional funding is available.

Following the presentation, Commissioner Kreyenhagen motioned to fund the remaining \$6,000 that was not allocated during the original \$10k request back in February, seconded by Commissioner Monares. Commissioners Urquhart, Hosfelt, and Sargenti abstained as they are recipients of the program. Motion passed 9-0.

Old Business

- a) Fish and/or Wildlife Research Grant Update
 Ideas and criteria have been discussed. Subcommittee to meet again to continue work on a proposal. Continued to next meeting.
- b) Fish & Game Commission Website Development

 The website is in the works, using the Mendocino County Commission's as an example.

 Cost is expected to be <\$2k (8 hours @ \$200/hr). Plan is to train a county employee to help maintain the site once it's developed to help keep recurring costs down.

 Commissioners DeHart and Guilliam expressed interest in turning the grant application into a fillable PDF that can be available on the website and hopefully make submission easier for everyone.
