WHEREAS, Deputy Jose A. Gonzalez worked as a reserve with the Salinas Police Department before being hired as a Deputy Sheriff with the Monterey County Sheriff's Office at the age of 25 in September of 1995, receiving the Oath of Office from Sheriff Norman G. Hicks and over his career had served during the terms of Sheriff Gordon Sonne, Sheriff Mike Kanalakakis, Sheriff Scott Miller, and Sheriff Steve Bernal; and

WHEREAS, Deputy Jose A. Gonzalez, during his twenty-five and half years of service with the Monterey County Sheriff's Office, held the positions of Deputy Sheriff, Sheriff's Explorer Advisor, Corrections Facility Training Officer (FTO), Critical Emergency Response Team member (CERT), Sheriff's Motor Squad Advisor, CERT Armorer, and as a Bailiff for Judge Lydia M. Villarreal in the Court Service Unit at the Superior Courts of Monterey County; and

WHEREAS, Deputy Jose A. Gonzalez, as a result of his hard work, exceptional performance, and dedication to the Monterey County Sheriff's Office, was awarded multiple Letters of Appreciation, Letters of Commendation, Memorandums of praise from Sheriffs and Chiefs of Monterey County and different agencies, and received a Medal of Valor for his efforts during a Jail riot; and

WHEREAS, Deputy Jose A. Gonzalez retired at the rank of Deputy Sheriff in March of 2021 and will enjoy the adventures that come from traveling.
