Adopt a Resolution commending Fire Captain **Jeff May** for his thirty years of service to the communities of Monterey County and acknowledge we live in a safer community because of his selfless efforts.

WHEREAS Fire Captain May started his career in the fire service as a Volunteer Firefighter with the Salinas Rural Fire Protection District of Monterey County on February 28, 1992, was promoted to Firefighter on February 1, 1995, promoted to Lieutenant on December 27, 2003, and promoted to Fire Captain on May 19, 2018; and

WHEREAS in his role as Firefighter, Lieutenant, and Fire Captain, he worked on numerous committees and special projects including the Buildings and Grounds Coordinator, Training Committee Member, and Urban Search and Rescue Team Coordinator; and

WHEREAS Fire Captain May protected the citizens of the District from major incidents including; the Soberanes Fire, River Fire, Salinas River Floods of 1995 and 1997, River Fire debris flow, in addition to company assignments of structure fires, vegetation fires, vehicle accidents, aviation accidents, hazardous materials incidents, medical aids and rescues; and

WHEREAS Fire Captain May was a hands-on, salt-of-the-earth leader who was often found in or put into critical positions within the incidents due to his “can do” and ”get it done” attitude. He led by example, pushing himself and his crew to accomplish the assigned tasks while always looking out for their safety; and

WHEREAS Fire Captain May was a State Certified Firefighter 1, Company Officer, Emergency Medical Technician, and completed coursework in Fire Command, Fire Management, Fire Investigation, Hazardous Materials, Rope Rescue, Confined Space Rescue, Trench Rescue, Tower Rescue, Backcountry Rescue, Building Collapse Rescue, and the Incident Command System; and

NOW, THEREFORE, BE IT RESOLVED that the Monterey County Board of Supervisors on behalf of the County and all residents thereof, acknowledges, commends, and thanks Jeff May for the thirty years of service to the County of Monterey.

BE IT FURTHER RESOLVED THAT the Monterey County Board of Supervisors wishes Fire Captain **Jeff May** a long, healthy, and well-deserved retirement.
