WHEREAS, Deputy Gregory Borg as a product of his dedication to excel in his personal life, had attended California State University, Sacramento in 1994 acquiring a Bachelor of Science degree in Criminal Justice; and

WHEREAS, Deputy Gregory Borg worked at Sacramento Probation, Santa Clara Probation and at the age of 24, was hired as a Deputy Sheriff with the Monterey County Sheriff's Office on February 12, 1996, receiving the Oath of Office from Sheriff Norman G. WHEREAS, Deputy Gregory Borg during his twenty-five years of service with the Monterey County Sheriff's Office, held the positions of Deputy Sheriff, Corrections Facility Training Officer (FTO), Classification Deputy, Department Training Coordinator, and as a Bailiff for Judge Thomas W. Wills in the Court Service Unit at the Superior Courts of Monterey County; and

WHEREAS, Deputy Gregory Borg as a result of his hard work, exceptional performance, and dedication to the Monterey County Sheriff's Office, was awarded the Monterey County Peace Officer award in the year 2003 and had been presented with multiple Letters of Appreciation, Letters of Commendation, and memorandums of praise from Sheriffs and Chiefs of Monterey County and different agencies; and

WHEREAS, Deputy Gregory Borg met his wife Ursula Borg in 2001, married in 2002, had two handsome boys, and will be spending time enjoying the adventures that come from boating, fishing, horse riding, and playing music.
