**AMENDMENT #4 TO PROFESSIONAL SERVICES AGREEMENT
COUNTY OF MONTEREY & RESTORATIVE JUSTICE PARTNERS, INC.**

THIS AMENDMENT is made to the AGREEMENT A-14712 for Victim Impact Program and curriculum and in-person victim speakers to the Monterey County Adult Correctional Facility by and between **RESTORATIVE JUSTICE PARTNERS, INC.**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on July 1, 2018, with a not to exceed amount of \$44,133.00 and a term ending date of June 30, 2019; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT with Amendment #1 on June 3, 2019 by adding \$50,594.00 and extending the term one (1) year with a new term ending date of June 30, 2020; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT with Amendment #2 on May 27, 2020, by adding \$68,261.00 and extending the term for one (1) year with a new term ending date of June 30, 2021; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT on June 22, 2021, by adding \$68,261.00 and extending the term for one (1) year with a new term ending date of June 30, 2022; and

WHEREAS, the County and CONTRACTOR wish to further amend the AGREEMENT by adding \$68,261.00 and extending the term for one (1) year with a new term ending date of June 30, 2023.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 1., "PAYMENT PROVISIONS" shall be amended by removing, *"The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$231,249.00"*, and replacing it with, *"The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$299,510.00"*
2. Section 3., "TERM OF AGREEMENT" shall be amended by removing, *"The term of this Agreement is from 7/1/2018 to 6/30/2022"* and replacing it with, *"The term of this Agreement is from 7/1/2018 to 6/30/2023"*.
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on July 9, 2018.
