SUMMARY/DISCUSSION:

The Employee Wellness Program (EWP) will provide an PowerPoint presentation about the Program's activities and impacts in 2021 and 2022.

The EWP work aims to build healthy working environments, policies, and holistic programs that support and enhance employees' physical, psychological, financial, personal, and career well-being. The purpose of the Program is to build a healthy workforce by implementing the following wellness strategies and focus areas: (1) increase employees' knowledge about health, prevention, and management of chronic diseases, (2) encourage employees' involvement in their own health decisions, (3) encourage employees' adoption of healthy lifestyle habits, and (4) facilitate recommendations for organizational change that promote a safe and healthy work environment.

The Employee Wellness Program collaborates with internal and external departments and organizations to maximize our impact and leverage a "whole person" perspective. The EWP coordinator recently presented at the Department Heads' meeting on May 25th the findings of the 2022 Countywide Employee Wellness Program and Employee Engagement Survey, in which we reached 2,979 employees. More than double the number of employees reached in 2021. While final 2022 participation data for all wellness activities is not available we expect participation data will also show an increase from last year. Below is the final participation data for 2021.
