AMENDMENT #1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & COLUMBIA ULTIMATE INC.

THIS AMENDMENT is made to the STANDARD AGREEMENT for the provision of a hosted VolP PBX with Voice Mail, Multi-line calling service to aid in the collections of Court Fines and Fees. The service will also provide a IVR for 24/7 customer service for payments and account inquiries. By and between **Columbia Ultimate Inc,** hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect the County's exercise of the option to extend for one (1) additional year and increase the value of the agreement by an additional \$15,000.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2., "PAYMENTS PROVISIONS" shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$68,000.00." and replacing it with "The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed \$83,000.00"
- 2. Paragraph 3, "TERM OF AGREEMENT", shall be amended by removing "The term of this Agreement is from December 12, 2018 to June 30, 2022, unless sooner terminated pursuant to the terms of this Agreement", and replacing it with "The term of this Agreement is from December 12, 2018 to June 30, 2023, unless sooner terminated pursuant to the terms of this Agreement".
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated November 30, 2018.
