

**RENEWAL AND AMENDMENT NO. 1
TO SERVICES AGREEMENT
BETWEEN F1 TECHNICAL SOLUTIONS, INC. AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
CONSULTING SERVICES AND SUPPORT FOR TEMPORARY AND PERMANENT
PLACEMENT SERVICES**

This Renewal and Amendment No. 1 to the Services Agreement (“Agreement”) which was effective on March 15, 2022 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (“NMC”), and F1 Technical Solutions, Inc. (“CONTRACTOR”); **From this point forward, the party referenced previously as “NMC” shall be referenced as “COUNTY” and collectively, COUNTY and CONTRACTOR are referred to as the “Parties” to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed with F1 Technical Solutions, Inc. for consulting services and support for temporary and permanent placement services with a term March 15, 2022 through March 14, 2024 and a total Agreement amount not to exceed \$650,000; and

WHEREAS, the Agreement expired on March 14, 2024; and

WHEREAS, COUNTY and CONTRACTOR currently wish to renew and amend the Agreement via Renewal and Amendment No. 1 retroactive to March 15, 2024, to extend the term for an additional two (2) year period through March 31, 2026 for a revised term of Agreement (March 15, 2022 through March 31, 2026) to allow for services to continue with a \$250,000 increase for a revised total Agreement amount not to exceed \$900,000.

AGREEMENT

NOW, THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, “PAYMENTS BY COUNTY” shall be amended to the following:
“The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$900,000.”
2. The first sentence of Section 3.1 /Paragraph titled, “TERM OF AGREEMENT” shall be amended to the following:
“The term of this Agreement is from March 15, 2022 through March 31, 2026 unless sooner terminated pursuant to the terms of this Agreement.”
3. If there is any conflict or inconsistency between the provisions of the Agreement or this Renewal and Amendment No. 1, the provisions of this Renewal and Amendment No. 1 shall govern.
4. A copy of this Renewal and Amendment No. 1 shall be attached to the Agreement.
5. This Renewal and Amendment No. 1 is effective retroactively on March 15, 2024.


