**RENEWAL AND AMENDMENT NO. 6  
TO THE SERVICES AGREEMENT  
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND  
TEGRIA SERVICES GROUP – US, INC.  
FOR  
IT CONSULTING SERVICES**

This Renewal and Amendment No. 6 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter “County”), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, “NMC”), and Tegria Services Group – US, Inc. (hereinafter “CONTRACTOR”); **From this point forward, the party referenced previously as “NMC” shall be referenced as “COUNTY” and collectively, COUNTY and CONTRACTOR are referred to as the “Parties” to this Agreement, with respect to the following:**

**RECITALS**

**WHEREAS**, the Agreement was executed for IT Consulting Services per Request for Proposal (RFP) 9600-67 with a term January 11, 2017 through January 10, 2018. Multiple Agreements were awarded with an aggregate total not to exceed \$3,864,000 for all agreements which was approved by the Monterey County Board of Supervisors. Each individual Agreement did not have its own not to exceed dollar amount; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on January 11, 2018 via Amendment No. 1 to extend the term for an additional one (1) year period through January 10, 2019 with the option to extend the agreement for three (3) additional one year periods; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on December 12, 2018 via Amendment No. 2 to extend the term for an additional one (1) year period through January 10, 2020 with the option to extend the agreement for two (2) additional one year periods; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on October 23, 2019 via Amendment No. 3 to extend the term for an additional one (1) year period through January 10, 2021 with no change to the original scope of work or the total aggregate dollar amount with the option to extend the agreement for one (1) additional one year period; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on December 8, 2020 via Amendment No. 4 to extend the term for an additional one (1) year period through January 10, 2022 with no change to the original scope of work with an aggregate increase of \$4,200,000; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on December 15, 2021 via Amendment No. 5 to extend it for an additional two (2) year period through January 10, 2024 to allow for services to continue with a \$2,650,000 aggregate increase and no changes to the scope of work; and

**WHEREAS**, the Agreement expired on January 10, 2024; and

**WHEREAS**, COUNTY and CONTRACTOR wish to renew and amend the Agreement retroactive to January 11, 2024 to extend the term for an additional three (3) year period (January 11, 2024 through January 10, 2027) for a revised full Agreement term of January 11, 2017 through January 10, 2027 to allow for continued need of CONTRACTOR’s services with no change to the scope of work with an aggregate increase of \$6,728,679 for a total aggregate Agreement amount not to exceed \$24,534,679.

## AGREEMENT

**NOW THEREFORE**, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement incorporated herein by this reference, except as specifically set forth below.

1. The "TERM OF AGREEMENT" Section in the Agreement shall be amended to the following:  
**"The term of this Agreement is from January 11, 2017 through January 10, 2027 unless sooner terminated pursuant to the terms of this Agreement".**
2. The "PAYMENTS BY NMC" Section in the Agreement shall be amended to the following:  
**"The total amount payable by COUNTY to CONTRACTOR shall not exceed the sum of \$24,534,679."**
3. If there is any conflict or inconsistency between the provisions of Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5 or this Renewal & Amendment No. 6, the provisions of this Renewal and Amendment No. 6 shall govern.
4. This Renewal and Amendment is effective retroactively on January 11, 2024.
