IX, Sec. 9, on behalf of its UCSF School of Medicine, Department of Pediatrics ("UCSF"), and the County of Monterey ("County") on behalf of Natividad Medical Center ("Hospital") entered into a Professional Services Agreement with an effective date of July 1, 2021 and subsequently, a First Amendment with an Effective date of January 1, 2022, and a Second Amendment with an Effective date of July, 2022, and a Third Amendment with an Effective date July 1, 2023 (collectively "Agreement");

WHEREAS, UCSF and County wish to amend the pediatric hospitals clinical services ("Services") UCSF provides to the Hospital;

WHEREAS, Natividad desires to continue to engage UCSF to provide Services under the Agreement;

WHEREAS, the UCSF desires to continue to provide Services under the Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in this Agreement, the parties mutually agree to amend the Agreement as follows:

- 1. This Amendment 4 is effective as of July 1, 2024 (the "Effective Date")/
- 2. The term of the Agreement is extended through June 30, 2026.
- 3. <u>Section 5.1</u>. Section 5.1 to the Agreement is hereby amended and restated to read in its entirety as follows: "5.1 Term. This Agreement shall become effective on July 1, 2021 (the "Effective Date"), and shall continue until June, 30, 2026 (the "Expiration Date"), subject to the termination provisions of this Agreement."

Except as hereinabove stated, all of the terms and conditions of the Agreement remain in full force and effect.
