RENEWAL AND AMENDMENT NO. 3 TO THE SERVICES AGREEMENT BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND EBSCO INDUSTRIES, INC. FOR ONLINE DATABASE AND JOURNAL SUBSCRIPTIONS

This Renewal and Amendment No. _______ to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "NMC"), and EBSCO Industries, Inc. (hereinafter "CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for EBSCO Industries, Inc. with a term January 1, 2019 through December 31, 2019 and a total Agreement amount not to exceed \$99,600; and

WHEREAS, Licensee and EBSCO amended the Agreement via Amendment No. 1 to extend the term for an additional three (3) year period through December 31, 2022 for a revised full Agreement term of January 1, 2019 through December 31, 2022 with no additional services added to the scope and to add an additional \$348,553, thereby increasing the total Agreement amount to \$448,153; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement via Amendment No. 2 on May21, 2022 to allow for services to continue with a \$125,000 increase for a total Agreement amount of \$573,153; and

WHEREAS, the Agreement expired on December 31, 2022; and

WHEREAS, the Parties wish to renew and amend the Agreement on the same or similar terms, beginning January 1, 2023 and to extend the term for an additional three (3) year period (January 1, 2023 through December 31, 2026) for a revised full Agreement term of January 1, 2019 through December 31, 2026 to allow for services to continue with additions to the original scope of work attached hereto as "Exhibit A-3 as per Renewal and Amendment No. 3" and to increase the amount payable by \$383,206 for a total Agreement amount of \$956,359.

AGREEMENT

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement incorporated herein by this reference, except as specifically set forth below.

- "TERM OF AGREEMENT" Section shall be amended to the following: "The term of this Agreement is from January 1, 2019 through December 31, 2026 unless sooner terminated pursuant to the terms of this Agreement".
- "PAYMENTS BY NMC" Section shall be amended to the following:
 "COUNTY" shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A and Exhibit A-3, subject to the limitations set forth in this Agreement and in this Renewal and Amendment No. 3. The total amount payable by COUNTY to CONTRACTOR shall not exceed the sum of \$956,359."

- 3. "SCOPE OF SERVICES AND ADDITIONAL PROVISIONS/EXHIBITS" Section shall be amended to the following: *"The following attached exhibits are incorporated herein by reference and constitute a part of the Agreement: Exhibit A: Scope of Services/Payment Provisions Exhibit A-3: Revised Scope of Services/Payment provisions as per Renewal and Amendment No. 3."*
- 4. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 3, the provisions of this Renewal and Amendment No. 3 shall govern.
- 5. This Renewal and Amendment is effective retroactively on January 1, 2023.
