

**RENEWAL AND AMENDMENT NO. 1  
TO THE SERVICES AGREEMENT  
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND  
INFOIMAGE CALIFORNIA, INC.  
FOR  
MEDICAL BILL MAILING SERVICES**

This Renewal and Amendment No. 1 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "NMC"), and InoImage of California, Inc. (hereinafter "CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

**RECITALS**

**WHEREAS**, the County of Monterey on behalf of Natividad Medical Center and Infolmage of California, Inc. had previously entered into an Agreement for Services (hereinafter "Agreement") on May 18, 2016 to provide medical bill mailing services to NMC with a five-year term and a total Agreement amount not to exceed \$300,000 and

**WHEREAS**, the Agreement expired on June 30, 2021; and

**WHEREAS**, the Parties wish to renew and amend the Agreement on the same or similar terms, beginning July 1, 2021 and to extend the term for an additional one (1) year period (July 1, 2021 through June 30, 2022) for a revised full Agreement term of July 1, 2016 through June 30, 2022 to allow for services to continue an increase the amount payable by \$30, 000 for a total Agreement amount of \$330,000.

**AGREEMENT**

**NOW THEREFORE**, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement incorporated herein by this reference, except as specifically set forth below.

1. "TERM OF AGREEMENT" Section shall be amended to the following:  
"The term of this Agreement is from July 1, 2016 through June 30, 2022 unless sooner terminated pursuant to the terms of this Agreement".
2. "PAYMENTS BY NMC" Section shall be amended to the following:  
***"COUNTY" shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A to the limitations set forth in this Agreement and in this Renewal and Amendment No. 1. The total amount payable by COUNTY to CONTRACTOR shall not exceed the sum of \$330,000."***
3. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 1, the provisions of this Renewal and Amendment No. 1 shall govern.
4. This Renewal and Amendment is effective retroactively when both parties have signed.
