Establishing County Service Area }
No. 25

*Carmel Valley Golf
and Country Club
Subdivisions*

A written request signed by two members of the Board of Supervisors having been filed with this Board requesting the institution of proceedings for the establishment of a County Service Area, and

A resolution of intention to form a County Service Area having been adopted, and

The said matter having been set for public hearing on November 25, 1963 at the hour of 11:00 o'clock a.m. at the Chambers of the Board of Supervisors in the Courthouse, Salinas, California, and due and proper notice having been given of such hearing as required by law, and November 25, 1963 having been declared a holiday, and

The matter of the establishment of said County Service Area having come on for hearing at 11:00 o'clock a.m. on November 26, 1963 at the place so fixed, and this Board having heard and considered the same and there being no protests thereto, either oral or written, now therefore:

BE IT RESOLVED:

1. That a County Service Area is hereby established.
2. That it is found and declared that the services described in the resolution of intention, and hereinafter set out in Exhibit "B", attached hereto and made a part hereof, are extended county services.

3. That it is declared, finally determined and established that the boundaries of said County Service Area are as set out in said resolution of intention and in Exhibit "A", attached hereto and made a part hereof.

4. That said County Service Area shall be known and designated as "County Service Area No. 25."

On motion of Supervisor Hudson, seconded by Supervisor Deaver, the foregoing resolution is adopted this 26th day of November, 1963, by the following vote:
