AN ORDINANCE OF THE COUNTY OF MONTEREY, STATE OF CALIFORNIA,  
ESTABLISHING WEST LAUREL DRIVE AS A FREEWAY AND INDICATING CERTAIN ACCESS

4 • THERETO.

5 The Board of Supervisors of the County of Monterey, State of  
6 California, do ordain as follows:

7 Section 1. West Laurel Drive, as shown on maps of and entitled,  
8 "Location Map Showing West Laurel Drive a Freeway", consisting of one sheet, and  
9 "West Laurel Drive a Freeway in Accordance with Section 941.1 of the  
Streets and Highways Code, State of California", consisting of three (3) sheets, which  
maps are attached hereto and made a part hereof., is designated a Freeway in accordance  
with Section 941.1 of the Streets and Highways Code, State of

• II California.

Section 2. Access points for vehicular ingress and egress are hereby  
established as shown on map of and entitled "West Laurel Drive a Freeway in Accordance  
with Section 941.1 of the Streets and Highways Code, State of California", consisting  
of three (3) sheets.

No additional or other access points shall be allowed or any existing access  
point be moved unless or until said locations are approved by the Board of Supervisors  
in accordance with Section 3 hereof.

Section 3. The Board of Supervisors of the County of Monterey, State of  
California, may approve the relocation of existing access points or additional access  
points by the following procedure.

1. Application for the above mentioned change in access shall be in letter  
form addressed to the Board of Supervisors indicating need or reason for said change  
and accompanied by map or maps of sufficient detail to clearly show the proposed change.

2. Said Board of Supervisors shall thereupon refer said application to  
the County Planning Commission.

26 3. Upon receipt of any such application, the County Planning Commission  
27 shall hold at least one public hearing thereon, notice of which shall be given by  
28 one publication in a newspaper of general circulation in said County of Monterey  
at least five (5) days prior to such hearing.

1 4. At said hearing the applicant shall present adequate evidence  
2 for the Commission to properly consider necessity or need for such change.

3 5. The County Planning Commission shall thereupon make its decision  
4 upon said application and shall report such decision to the Board of Supervisors  
5 In recommending approval, the County Planning Commission shall designate such  
6 conditions in connection therewith which, in its opinion, are necessary to  
7 protect the purpose of this ordinance.

8 6. Upon the receipt of such report, the Board of Supervisors shall  
9 by resolution make its decision upon the aforesaid application in whatever  
10 manner said Board deems advisable. If such action is to approve or conditionally  
11 approve said application, the permit applied for shall be issued by the Board  
12 of Supervisors. The Board of Supervisors may designate such conditions in  
13 connection with the permit as it may deem necessary to secure the purposes of  
14 this ordinance and may require guarantees or evidence to insure said conditions  
15 being complied with.

16 Section 4. If any section, sub-section, sentence, clause or phrase  
17 of this ordinance, is for any reason held by a court of competent jurisdiction  
18 to be invalid, such decision shall not affect the validity of the remaining  
19 portions of this ordinance. The Board of Supervisors hereby declares that it  
20 would have passed this ordinance and each section, sub-section, sentence,  
21 clause and phrase thereof, irrespective of the fact that any one or more  
22 sections, sub-sections, sentences, clauses, or phrases be declared invalid.

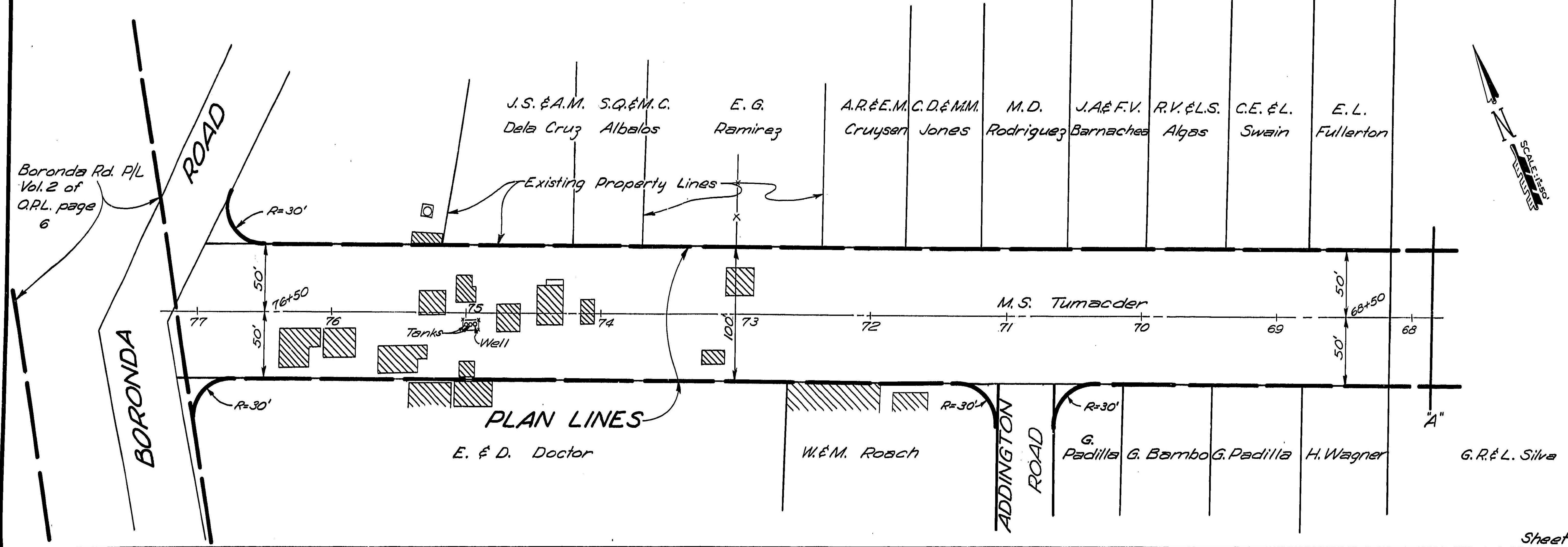
