# AMENDMENT NO. 6 TO AGREEMENT NO. A-13188 BY AND BETWEEN COUNTY OF MONTEREY AND UNUM

**THIS AMENDMENT** is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of disability insurance by and between **UNUM**, hereinafter "CONTRACTOR," and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County."

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to change the ending term date.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 4.0 "TERM OF AGREEMENT," paragraph 4.1 shall be amended by removing "The term shall commence February 1, 2015 through and including February 29, 2020, with the option to extend the AGREEMENT upon mutual consent. County is not required to state a reason if it elects not to renew this AGREEMENT." and replacing it with "The term shall commence February 1, 2015 through and including June 30, 2022, with the option to extend the AGREEMENT upon mutual consent. County is not required to state a reason if it elects not to renew this AGREEMENT."
- 2. Effective March 1, 2020, **EXHIBIT B-3 COST** to the Agreement shall be deleted and replaced in its entirety by **EXHIBIT B-4 COST** attached hereto.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of this AMENDMENT shall be attached to the original AGREEMENT signed and dated by the County Contracts/Purchasing Officer on June 27, 2016.
