WHEREAS, Monterey County, the cities of Salinas, Gonzales, Soledad, and King, the Monterey County Water Resources Agency, the Castroville Community Services District, and Monterey One Water (formerly the Monterey Regional Water Pollution Control Agency) formed the Salinas Valley Basin Groundwater Sustainability Agency ("SVBGSA"), a Joint Powers Authority ("JPA"); and,

WHEREAS, the SVBGSA is governed by an 11-member Board of Directors ("SVBGSA Board"), with Directors appointed by specific Members of the JPA; and,

WHEREAS, the County Board of Supervisors is the appointing authority for seven Director positions on the SVBGSA Board: 1) one "Other GSA Eligible Entity" position; 2) four "Agricultural" positions representing the Eastside Sub-basin area, the Forebay Sub-basin area, the Pressure (180/400) Sub-basin area, and the Upper Valley Sub-basin area; 3) one "Environment" position; and 4) one "Public Member" position; and,

WHEREAS, each Director position has a Primary and an Alternate Director; and,

WHEREAS, the permanent SVBGSA Board was established effective July 1, 2017, and the Other GSA Eligible Entity Directors were given initial thee-year terms, expiring on June 30, 2020, and thereafter three-year terms to create staggered terms for the entire Board of Directors; and,

WHEREAS, the current terms of the Other GSA Eligible Entity Directors expire on June 30, 2023; and,

WHEREAS, the County has received expressions of interest for the Other GSA Eligible Entity Director positions; and,

WHEREAS, the Board of Supervisors has considered the individuals who have expressed interest in the Other GSA Eligible Entity Director positions; NOW, THEREFORE,

1. The above recitals are true and correct. 2. is hereby reappointed as the Primary Director to the Other GSA Eligible Entity Director position for a term ending June 30, 2026. 3. is hereby reappointed as the Alternate Director to the Other GSA Eligible Entity Director position for a term ending June 30, 2026. 4. Staff is authorized and directed to take such other and further actions as may be necessary or appropriate to implement the intent and purposes of this Resolution.
