

**Amendment No. 1 to Standard Agreement Between
the County of Monterey and BMI Imaging Systems
(Amendment No. 1 - Additional Funds – September 1, 2022 to June 30,
2024)**

This Amendment No. 1 to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, “COUNTY”) and BMI Imaging Systems, Inc. (hereinafter, “CONTRACTOR”) is hereby entered into between the COUNTY and CONTRACTOR (collectively, the “parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, on August 23, 2022, COUNTY Board of Supervisors approved and authorized a Standard Annual Agreement (“Agreement”) between the parties effective September 1, 2022, for an initial term from September 1, 2022 through June 30, 2024, in an amount not to exceed \$47,720.

WHEREAS, now, the parties desire to amend the Agreement, on the same or similar terms, for an additional \$3,600 for the term of September 1, 2022 through and including June 30, 2024 (hereinafter, “Amendment No. 1 – Additional Funds”).

WHEREAS, this “Amendment No. 1 – Additional Funds” is necessary due to the COUNTY’S business need to maintain compliance with Assembly Bill 1466 through the continued operation of a program to assist with the redaction of unlawfully restrictive covenants.

NOW THEREFORE, the parties agree as follows:

1. Section 2.0, which states “The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of: **\$47,720**” shall be amended to state “The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of: **\$51,320.**”
2. If there is any conflict or inconsistency between the provisions of the Agreement or its subsequent amendments, the following shall have precedence:
 - Amendment No. 1 over the Agreement.
3. The recitals of this Amendment No. 1 are incorporated into the Agreement and this Amendment No. 1.
4. A copy of this Amendment No. 1, shall be attached to the original Agreement approved by said Board on August 23, 2022.
5. All other terms and conditions in the Agreement remain in full force and effect.
6. This Amendment No. 1 shall become effective immediately upon execution of the parties.
