## Amendment No. 7

## County of Monterey Agreement for Professional Services with Ballard Spahr LLP for Federal Legislative Advocacy Services

This AMENDMENT NO. 7 to the County of Monterey Agreement for Professional Services (hereinafter, "AMENDMENT") is made and entered into, by and between the County of Monterey, a political subdivision of the State of California (hereinafter, "COUNTY"), and Ballard Spahr LLP (hereinafter, "CONTRACTOR").

Whereas, the parties entered into an Agreement for Professional Services (hereinafter, "AGREEMENT"), on January 29, 2019, with a 5-month term ending on June 30, 2019, and a total AGREEMENT amount not to exceed \$29,731.19; and,

Whereas, the parties renewed and amended the AGREEMENT from time-to-time to extend the Agreement and increase the contract amount not to exceed;

Whereas, the parties desire to further amend the AGREEMENT to increase the amount not to exceed for federal legislative advocacy services; NOW, THEREFORE,

The parties agree to amend the AGREEMENT effective July 1, 2024, as follows:

- 1. Section 2.0 PAYMENT PROVISIONS, shall be amended by removing "The total amount payable by the County to CONTRACTOR under this Agreement shall not exceed the sum of \$548,231.69" and replacing it with "The total amount payable by the County to CONTRACTOR under this Agreement shall be increased by the amount of \$125,000 for a total contract amount not to exceed the sum of \$673,231.69."
- 2. Except as provided herein, all other terms and conditions of the original AGREEMENT and AMENDMENT Nos. 1, 2, 3, 4, 5 and 6 as amended by this AMENDMENT NO. 7, shall remain in full force and effect.
- 3. A copy of this AMENDMENT NO. 7 shall be attached to the original AGREEMENT and AMENDMENT Nos. 1, 2, 3, 4, 5 and 6.
