THIS AMENDMENT is made to the AGREEMENT A-13600/14944 RFP-10582 for evidence-based practices reentry services program for the Monterey County Sheriff's Office, by and between **GEO REENTRY SERVICES**, **LLC**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on July 1, 2017, with a Not to Exceed amount of \$900,000.00 and a term date ending June 30, 2020; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT A-13600, with Amendment #1 on May 27, 2020, by adding \$297,000.00 and extending the Agreement one (1) year, with a new ending date of June 30, 2021; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT A-13600, with Amendment #2 on June 3, 2021, by adding \$297,000.00 and extending the Agreement one (1) year, with a new ending date of June 30, 2022; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT A-13600, with Amendment #3 on June 29, 2022, by adding \$297,000, for a new not to exceed total of \$1,791,000 and extending the Agreement one (1) year, with a new ending date of June 30, 2023.

WHEREAS, the County and CONTRACTOR amended the AGREEMENT A-13600, with Amendment #4 on June 8, 2023, by adding \$297,000 to the AGREEMENT for a new not to exceed total of \$2,088,000 and extending the term of AGREEMENT by one (1) year (July 1, 2023 to June 30, 2024) with a new end date of June 30, 2024.

WHEREAS, the County and CONTRACTOR wish to further amend the AGREEMENT A-13600 by adding \$310,000 to the AGREEMENT for a new not to exceed total of \$2,398,000 and extend the term of AGREEMENT by one (1) year (July 1, 2024 to June 30, 2025) with a new end date of June 30, 2025

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 3., "TERM OF AGREEMENT" shall be amended by removing, "The initial term shall commence July 1, 2017 through June 30, 2024" and replacing it with, "The initial term shall commence July 1, 2017 through June 30, 2025."
- 2. Section 4., "COMPENSATION AND PAYMENTS"

 Page 6 4.1 shall be amended to read as follows "It is mutually understood and agreed by both parties that CONTRACTOR shall be compensated under this AGREEMENT in the amount of \$25,833.33 per month for 11 months and one (1) month in the amount of \$25,833.37.
