

**AMENDMENT NO. 2
TO THE AGREEMENT BETWEEN THE
COUNTY OF MONTEREY
AND
ONE WORKPLACE L. FERRARI, LLC, DBA PENINSULA BUSINESS INTERIORS**

This Amendment No. 2 to Agreement, No. A-14396, is made and entered into by and between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and One Workplace L Ferrari, LLC, DBA Peninsula Business Interiors, hereinafter referred to as “CONTRACTOR.”

WHEREAS, the COUNTY and CONTRACTOR entered into Agreement A-14396 with a start date of July 1, 2019 in an amount not to exceed \$200,000 for the provision of design, planning, delivery and installation services for new or existing office furniture or office panel systems on a per project basis; and

WHEREAS, the COUNTY and CONTRACTOR entered into AMENDMENT No. 1 to extend the term for an additional two (2) year period for a new term of July 01, 2019 through June 30, 2023 and to increase the total amount of the Agreement to \$500,000 to cover additional goods and services due to the extended term.

WHEREAS, the COUNTY and CONTRACTOR wish to amend AGREEMENT to extend the term for an additional two (2) year period for a new term of July 01, 2019 through June 30, 2025 and adding \$150,000 to increase the total amount of the Agreement to \$650,000 to cover additional goods and services due to the extended term.

NOW THEREFORE, both parties hereby agree to renew and amend the Agreement as follows:

1. **Section 2.0, “PAYMENT PROVISIONS”**, shall be amended by removing, “The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$200,000” **and replacing it with** “The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$650,000”.
2. **Section 3.0, “Term of Agreement”**, shall be amended by removing, “The term of this Agreement is from July 1, 2019 to June 30, 2021, unless sooner terminated pursuant to the terms of this Agreement” **and replacing it with** “The term of this Agreement is from July 1, 2019 to June 30, 2025, unless sooner terminated pursuant to the terms of this Agreement”.
3. All other terms and conditions of the Agreement remain unchanged and in full force. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
4. A copy of this Amendment No. 2 shall be attached to the original Agreement executed by the County on July 05, 2019.
5. This Amendment No. 2 is effective upon execution.
