Subject: Request for the State to Advance \$24 Million in CDAA Funding for Damages under DR-4683 & DR-4699

#### **Director Ward:**

The County of Monterey is respectfully requesting an advance under the California Disaster Assistance Act (CDAA) for funds currently expended and obligated in the amount of \$24,202,780 due to damages from the January Winter Storms (DR-4683) and March Winter Storms (DR-4699). The County experienced an atmospheric river weather pattern beginning March 9, 2023, which caused widespread flooding, notably along the Salinas and Pájaro Rivers with major damage occurring in residential communities, agricultural fields, and to critical county infrastructure surrounding these areas. The County has already identified \$30 million in damage and permanent repairs because of the January Storms and an additional \$40 million with the onset of the March Storms which created an even greater impact on the County's resources.

The County is requesting assistance and support from the State of California in response to the successive major disasters that have put a severe strain on the County's financial resources and will soon exhaust all its remaining Strategic Reserve funding. With the January (DR-4683), March (DR-4699), COVID-19 Pandemic (DR-4482) and 2020 Wildfires (DR-4558) the County's Strategic Reserve are near depletion. The current unprecedented expenditures are estimated to utilize all the County's Strategic Reserve, and without expedited financial support from the State, the County will be in difficult position and may not be able to continue to fund or provide resources should future emergencies occur. The table below lists the funds expended and obligated to date, along with a projected cost to complete the identified damages and projects for permanent repairs.
