**ENCAMPMENT RESOLUTION FUNDING GRANT PROGRAM

prior funding rounds that the council determined satisfied applicable program requirements but were not funded in the prior round. Any funds remaining after the awards required by subdivision (b) shall be awarded on a rolling basis in accordance with this subdivision.” Cal ICH has already funded projects from prior funding rounds under through ERF-3-L.

**This Notice of Intent to Award is for the applications received in the first application window of ERF-3-R. The total amount proposed to be awarded through this NOIA is \$191,859,313.05.**

This Notice of Intent to Award is subject to execution of a written contract and, as a result, this Notice does not constitute the formation of a contract between the State and the proposed awardees. Proposed awardees shall not acquire any legal or equitable rights relative to the contract services until a contract containing terms and conditions acceptable to the State is executed. The State further reserves the right to cancel and / or modify this Notice of Intent to Award at any time prior to the execution of a written contract.
