**WHEREAS, Detective Shaheen Jorgensen** was sworn in as a Deputy Sheriff in 1987 by Sheriff Bud Cook, she demonstrated excellent performance during her tour of duty at the Monterey County Sheriff's Office, where she held the positions of Corrections Deputy for three years, Patrol Deputy and Field Training Officer Corporal for seven years prior to being promoted to Detective; and

**WHEREAS, Detective Shaheen Jorgensen** was assigned to investigate reports of Narcotics, Sexual Assault, Property Crimes, Robbery Homicide, and maintained collateral assignment of Hostage Negotiation Team for eleven years, and pioneered the technological advancements and operations of specialized equipment to download the contents of computers and cellular phones within Monterey County; and

**WHEREAS, Detective Shaheen Jorgensen**, as a result of her hard work and dedication to the residents of Monterey County, received numerous Letters of Appreciation and Commendations from District Attorney's, multiple elected Sheriff's and appointed Police Chief's throughout the State of California during her tenure, detailing her superior work, determination, investigative and teaching skills, including the 2018 capture from Mexico; the suspect responsible for the rape and murder outside of Castroville, California of Christy Sue Pina in 1990; and
