# Medi-Cal Expansion for Individuals Ages 26 Through 49

Senate Bill (SB) 184 (Chapter 48, Statutes of 2022), amended Welfare and Institutions Code to expand eligibility for full scope Medi-Cal to individuals who are 26-49 years of age and who do not have satisfactory immigration status (SIS), if otherwise eligible effective January 01, 2024.

# Initial Implementation

- County of Monterey Department of Social Services (DSS) concurrently provided overviews of the expansion to over 50 agencies and communitybased organizations and posted information on social media platforms of Facebook and Instagram
- To engage hard to reach populations several community-based partners including the Health Department's Planning, Evaluation and Policy (PEP) team have conducted outreach, application support and expansion notifications across various locations, including farmers markets, food banks, WIC offices, laundromats, health fairs, agricultural fields, churches, and libraries.

# First Notice and Frequently Asked Questions (FAQ)

## Transition

The Statewide Automated Welfare System implemented system functionality to determine full scope Medi-Cal for individuals 26 through 49, and notices were mailed in December to inform impacted individuals.

# Public Charge (Immigration Status)

Clarifying: Applying for or using Medi-Cal does not affect an individual's immigration status.

The US Department of Homeland Security and US Citizenship and Immigration Services does not consider health, food and housing services as part of the public charge determination (except for residential nursing or mental health institution care).
